



# End User License Agreement for Japedo Persistence Documentation Tool

We ask you to read this end user license agreement thoroughly before you install and use Japedo Persistence Documentation Tool software. By installing or using this software you agree to be bound to the terms and conditions of this agreement. Do not install or use this software if you do not agree with the terms of the agreement.

This end-user license agreement is a legal agreement between you as an individual or a single entity and Logitags Software represented by Dr. Wolfgang Winter for trial and full versions of Japedo Persistence Documentation Tool.

## Definitions

In this agreement, the following terms shall have the meanings as indicated, both the singular and plural forms and all verb forms of these terms are defined:

**Software** means all of the contents of the files or other media for which this agreement is provided, including but not limited to a license key and software setup files and modified versions, updates, additions and copies of the software, if any, licensed to you by Dr. Wolfgang Winter.

**Use** implies to access, download, install or copy the software in accordance with the documentation and the license agreement.

**User** is a person who uses the version of the software or a license purchased through our web site.

## General
